

### PARISH BY-LAWS

### **ARTICLE I - NAME**

The name of the parish shall be St. Francis Episcopal Church which is incorporated under the laws of the State of Ohio as a corporation not-for-profit.

St. Francis Episcopal Church hereby acknowledges that it is a member of, and belongs to, the Protestant Episcopal Church in the United States of America and the Episcopal Dioceses of Southern Ohio. As such, it accedes to, recognizes and adopts the Constitution, Canons, Doctrine, Discipline, and Worship of the Episcopal Church, and the Constitution and Canons of the Diocese of Southern Ohio, and acknowledges their authority accordingly.

The purpose of these Parish By-Laws is to supplement Canon Law for the governance of St. Francis Episcopal Church and the management of its activities.

### ARTICLE II - PARISH MEETINGS AND SPECIAL (CALL) MEETINGS

The Rector/Priest in Charge, or a person designated by the Rector/Priest in Charge, shall preside at the Annual Meeting or Special (Call) Meetings. The quorum for any and all congregational meetings at St. Francis Episcopal Church shall be 50% of the eligible voters.

### ARTICLE III - MEMBERSHIP AND VOTING MEMBERS

All members of the Church in good standing aged sixteen (16) or older shall be eligible to vote for the election of a Vestry and on other Congregational matters, who at the time of voting shall have contributed, by subscription or otherwise, to the support of the Congregation and who shall be entitled to enrollment on the list of members in good standing of the Congregation.

### ARTICLE IV - QUALIFICATIONS: VESTRY MEMBERS, WARDENS, AND DELEGATES

### Vestry Members

One (1) of the members of the Vestry may be at least sixteen (16) years of age.

### Wardens

Wardens must be at least twenty-one (21) years of age and a Communicant of Good Standing at St. Francis Episcopal Church.

### Delegates

To be eligible to serve as a Delegate to the Diocesan Convention, a person must be a Communicant of Good Standing.

### ARTICLE V - VESTRY

The annual meeting of St. Francis Episcopal Church shall be sometime between the beginning of Advent and the end of Lent, at a date and time for which public notice shall have been given at least twenty (20) days in advance, for the purpose of electing a Vestry. Such a meeting shall be opened with prayer, and shall be conducted according to the Rules or By-Laws of this Congregation. If a Congregation be incorporated, the Vestry shall also be the Board of Trustees of the Corporation.

The Vestry shall consist of no fewer than five (5) nor more than nine (9) members, one of whom shall be Senior Warden and one Junior Warden, each have voice and vote, and all of whom shall continue in office until successors are chosen. Members of the Vestry shall be elected by ballot during the All Parish Meeting. The Vestry may, by a majority vote, elect to its body certain persons in the Congregation, not to exceed two (2) in number. Such appointed persons may serve one (1) or two (2) years as determined by the Vestry. Three (3) year terms for Vestry members and three (3) year terms for Wardens. After one (1) year off of the Vestry a person may be elected for the Vestry again.

Immediately following the All Parish Meeting the members of the Vestry shall meet to elect a Senior Warden and a Junior Warden from the Vestry membership.

In the event a member of the Vestry is suddenly unable to continue as a member, the Rector/Priest in Charge shall appoint a replacement to serve. After having been appointed by the Rector/Priest in Charge, the Vestry, at its next regular meeting, shall approve or disapprove the replacement by way of a majority vote.

#### Senior Warden

The Senior Warden shall have the duty of supporting and communicating extensively with the Rector/Priest in Charge or clergy in leadership capacity. The Senior Warden shall work very closely with the Financial Secretary and shall draft the church's budget for an oncoming fiscal year.

### Junior Warden

It shall be the duty of the Junior Warden, with the consent of the Vestry when needed, to manage and arrange for the care of the church's building and grounds. It shall further be the duty of the Junior Warden to submit a report to the Vestry of the physical plant's status at every monthly meeting.

### Duties of Both Senior and Junior Wardens

It shall be the duty of the Wardens, especially to provide the elements of the Lord's Supper, to collect the alms at the administration of the same, to keep and disburse such alms, to provide for the celebration of public worship, and the instruction of the congregation, by occasional clerical services, or by lay reading, as the circumstances may permit in case the Church is destitute of a Rector/Priest in Charge, and while the Church is destitute of a Rector/Priest in Charge. The Ecclesiastical Authority resides with the Senior Warden.

### Secretary of the Vestry

A Secretary of the Vestry shall be elected, appointed, or chosen by the Vestry. The duties of the Vestry Secretary shall be to take and record the minutes of all Vestry meetings, and preserve and keep them as the official record of Vestry action and procedure. The Vestry Secretary is to have voice, but no vote.

### To Be Bonded

The Financial Secretary and such other officers who are charged with the handling or custody of funds, shall be bonded according to the requirements of the Church's Canons.

### Audit

The Senior Warden will choose two (2) to four (4) Communicants of Good Standing who shall conduct an Audit of the church's finances with the assistance of the Financial Secretary. The Audit shall be conducted in enough time to meet the September deadline set by the Chief Financial Officer of the Diocese.

### **ARTICLE VI - VESTRY MEETINGS**

The Vestry of St. Francis Episcopal Church shall meet on the second (2) Tuesday of each month. All meetings shall commence when a majority (quorum) of Vestry members is present.

Pursuant to the Canons of the Episcopal Church, the Rector/Priest in Charge or such other member of the Vestry designated by the Rector/Priest in Charge, shall preside at all meetings of the Vestry.

Three (3) unexcused number of absences from regular Vestry meetings (in one (1) year) by any Vestry members could constitute de facto resignation from the Vestry.

### Special (Call) Meetings

Special (Call) Meetings of the Vestry shall be called by the Rector/Priest in Charge or by two (2) Vestry members whenever there are urgent issues of concern. No other business, except that which is set forth in the notice for the meeting, shall be transacted. In such an urgency, notification of date, time, and purpose (agenda) shall be a reasonable amount of time, if possible. The Presiding Officer at Special (Call) Meetings for the Vestry shall be the Rector/Priest in Charge or a person designated by the Rector/Priest in Charge.

### ARTICLE VII - AMENDEMENTS TO BY-LAWS

A motion or proposal to amend any segment of these By-Laws may be made by the Rector/Priest in Charge or any member of the Vestry. Any proposal or motion to amend these By-Laws must be approved with a majority vote by the Vestry.

### **MISSION OF THE VESTRY**

The Mission of the Vestry is to lead the congregation (in harmony with the Clergy) in fulfilling the Mission of the Parish.

### **EXPECTATIONS OF VESTRY MEMBERS**

- 1) Each Vestry member will endorse the Parish Mission.
- 2) Each Vestry member will lead the members of the Parish in words and actions that will help fulfill the Parish Mission.
- Each Vestry member will make a generous pledge of time, talent and treasure to the Mission of St. Francis.
- 4) Each Vestry member will pledge to work as a team member with all other members of the Vestry, and to serve as a team member or leader for one or more Ministry Teams.
- 5) Each Vestry member will pledge to hold information shared in Executive Session as a private communication.
- 6) Each Vestry member will assure that each ministry team in which they hold membership has backup leadership in order to maintain continuity in the ministry.
- 7) Each Vestry member pledges to be regular in attendance at Sunday Worship.
- 8) Each Vestry member pledges to be present at all Vestry functions unless previously coordinated by the Sr. Warden or Clergy.
- 9) Each Vestry member promises to abide by the Constitution and Canons of The Episcopal Church, the Constitution and Canons of the Diocese of Southern Ohio, and the By-Laws of Saint Francis Episcopal Church.

### Senior Warden Report

St Francis Episcopal Church faced many challenges during 2023. As our membership declined it was decided upon the recommendation from Priest in-in-charge, Rev. Dr. David Bailey to shrink the Vestry from 9 members to 6 members. So, we began 2023 with a 6-member vestry, 2 from 2022 vestry and 4 new members. Our challenge in 2023 was to redefine our roles to maintain St Francis Church as a continuing presence for its current members and that of a member in the Springboro community.

To promote our Parish in the Springboro community and to assist member parishioners who are unable to attend worship services, our internet broadcast equipment was upgraded utilizing a targeted funds grant from the Diocese of Southern Ohio. Under the direction of Seth & Elliot Broweleit, a new computer and cameras were installed which enabled St Francis worship services to be broadcasted out to the internet via our FaceBook account. Thank you, Seth & Elliott.

To maintain our place of worship, investments of time and dollars must be made to maintain our church building and grounds. These are overseen by our Jr Warden, Jacqui Parker, who spends countless hours overseeing the needed maintenance items, scheduling contractor quotes and also working with our volunteer parishioners in performing tasks that can be done in-house to keep our expenses as low as possible. Major maintenance items in 2023 included partial roof repair & replacement, Energy saving WI-FI enabled thermostats installed, re-keying our entrance doors to provide for better facility safety, replacing emergency exit lighting units, and our current fire alarm system was out of compliance of the current safety code and would need to be replaced. A quote was obtained and at some point, during a check of system wiring in the office area maintenance room the system popped back to life. It was then retested and certified in working order thus saving thousands of dollars that would have been spent on a new system. Exterior grounds maintenance continues to be another challenge with dying trees along our north & west property lines, electrical parking lot and building safety lighting needs to be addressed and upgraded. Finally, our building and grounds went through a facility inspection and audit that was provided by the Diocese to evaluate the present and future needs of our current campus. We are currently waiting for the report. Maintaining our building and grounds will continue to be a challenge and an ongoing expense to our parish.

Our worship committee faced a major challenge during the last year. Fr David's planned retirement was moved forward to August due to circumstances beyond our control. This left our parish without a resident priest, and we are now relying on supply clergy to act as weekly Eucharistic celebrants. When none are available our 2 certified lay ministers, Stephan Graham & Jeff Baldrige will step in and lead our parish in a morning prayer service. Jeff Baldrige and his wife Teena have also stepped forward and they lead a mid-week morning prayer & healing service every Wednesday which is broadcasted on the internet. My heartfelt thanks go out to Steve, Jeff, Teena for the work they do and in addition to our organist Diana Graham and her backup organist Jenny Catalan for their music work that adds to our weekly services. Last to thank is Barb Roy who chairs our Altar Guild. Her group maintains our worship area including the altar and vestments and keeps it all in excellent shape. All in all, their hard work shows what beautiful church services are available at St. Francis Church on a weekly basis.

In closing I want to say it has been an honor to serve as Senior Warden along with a great vestry team at St. Francis Church during 2023. Yours in Christ, Tom Phillips, Senior Warden

#### Junior Warden Report

Saint Francis' building and grounds is a big property with many beautiful qualities. We are on our way to exposing its potential and hopefully creating some curb appeal. Thanks to the previous Junior Warden, David Culp, it has improved immensely through the efforts of a very dedicated crew of volunteers – Tom Phillips, Jack Rouse, and others.

The biggest challenge is our vast parking lot. We also have an area at the back of the lot, beyond the creek and the trees, that needs attention. Those are such big projects; they will stay on the back burner for a while. Jeff Baldrige has worked endlessly clearing that back tree area to keep the squatters away. The crew cleared away a large area of overgrown bush that had piled up beyond the shed at the edge of the parking lot.

Our next challenge is keeping our internet in efficient and working order. This is important to our online worshippers for streaming the services on Facebook. Thanks to the Broweleit family for keeping us online so efficiently.

Another issue is that we still need 2 more HVAC systems replaced. The next big project is replacing our 30+ year old roof. A partial replacement (on the worst part) has been done with an insurance claim due to the sever winds in early 2023. There are also a few other outside areas in need of improvement, that will have to wait until the weather is better. The Vestry will apply for grants from the diocese to help fund these projects as they are made available to us.

We had the 3 entry door locks re-keyed and everyone with a key should have a replacement now. We finally passed the fire inspection on our alarm system. Thanks to Tom Phillips for all the times he had to meet with the Clearcreek Fire Department, and many companies to figure out why it kept failing. By some small miracle, we averted a very expensive fix on this.

The Diocese had Smart Church Solutions come to assess the building in December. We will receive a report from this assessment. The crew has already made some of the small improvements that were suggested by the inspector.

There are always things that need to be one in our "house", some big and some small. I hope you take notice and appreciate tasks that get accomplished week to week on Tuesday afternoons. Anyone is welcome to come to help. No prior knowledge necessary. The work crew always finds something for me to do when I get time to go (even for just an hour, sometimes). The crew meets on Tuesdays at 1:30 pm.

### **Financial Committee**

We ended 2023 spending \$10,184 more than we received in income. This was an improvement vs our spendings in 2022. On the bright side, part of our roof was repaired due to storm damage and at the same time both sides of the section involved were stripped and replaced with new roofing. Total roofing expense was \$11,000+ with our building insurance reimbursement of \$7,335 leaving \$3,635 paid from our capital endowment fund. The remainder of our Diocesan Webcast grant of \$5,000 was spent to upgrade our broadcast computer and camera equipment.

Finally, our Fire Alarm System came back to life and in January 2024 was certified for 2024 and passed inspection saving us from spending \$10,000 on a new system. This was in addition to a savings of over \$15,000 due to lower spending and deficit than was expected.

Our Budget for 2024 has a projected income of \$68,596 and I'd like to thank everyone that pledged to support St. Francis. On the flip side, our projected expenses are \$94,723. As you can see, this is quite a bit more than our income. As a parish we need to work together to figure out a way to make our budgeted income and expenses come closer together. Working with building & grounds we will do our best to lower our expenses.
